Promotion Period

The Promotion will commence on Monday 23 October 2023 and conclude at 11:59pm on Monday 27 November 2023 unless all tickets are sold sooner. All times recorded throughout these Terms and Conditions are in Australian Western Standard Time.

Eligibility

Entrants must be 18 years of age or older and cannot purchase a ticket under the name, or for a minor. Entrants must be Western Australian residents. No person under the age of 18 years shall be permitted to sell tickets in the lottery. Persons under 18 years of age are prohibited from selling or purchasing a ticket in the lottery.

It is a condition of entry that the prize winners agree to have their name and suburb published for publicity purposes.

Prize Pool

Prize winners will be notified in writing and are responsible for making their own arrangements to claim their prize. The total retail value of all prizes is \$43,397.00 and includes 130 cases of premium wine.

Each eligible \$200 lottery ticket holder will receive a randomly selected case/s of premium wine worth a retail value of \$228 or more. Cases of wine may comprise 6, 12 or 18 bottles. Prizes are not exchangeable or redeemable for a substitute case of wine or cash and must be accepted as awarded.

Conduct of Draws

Notification and Collection

All prize draws will be conducted by online random number generator at Telethon Speech & Hearing.

The prize winner or winners of the lottery shall be determined by the drawing of tickets, numbers or lots. The major prize shall be awarded to the first ticket drawn, and prizes shall be ranked according to the drawing.

All prize winners will be notified in writing and results published on www.tsh.org.au on Monday 4 December 2023. Collection of wine must be made by persons 18 years or older from Telethon Speech & Hearing, 36 Dodd St, Wembley with legal photo identification shown before collection. All prize winners must collect their prizes within 21 working days of the completion of the Lottery. Instructions on how to claim prizes will be included in winner letters.

An unclaimed standard lottery prize must be held for a period of 12 months after which time the permit holder is required to notify the Commission in writing of the details prescribed in regulation 30. The disposal of the prize is subject to the direction of the Commission.

No person under the age of 18 years shall be permitted to sell tickets in the lottery. Persons under 18 years of age are prohibited from selling or purchasing a ticket in the lottery.

Prizes can be couriered to the winner. TSH can arrange this at a cost of \$25 (metro area only) to \$60 (interstate). For regional areas, costs will be calculated as per the destination. Payment must be made before delivery in person or via credit card over the phone.

Ineligible Entrants: All ineligible persons will be declined from purchasing a ticket and entering the Promotion to win any prizes.
